RE: Response to Independent Audit Report - SSDA 8766: Nepean Hospital Integrated Ambulatory Services (Stage 1)

As required by State Significant Development Application (SSDA) Consent 8766, Health Infrastructure NSW (HI), has received the attached Independent Audit Report from AQUAS.

HI has reviewed their report and confirm that the Independent Auditor has identified one (1) non-compliance and one (1) opportunity for improvement. HI will implement corrective procedures as outlined below:

A suggestion was made for all the Approved Plans to be posted in one location in the project website. It was noted that some Plans were posted in the Health Infrastructure website and others in the NSW Planning Portal website under Modification 2 - Design Refinements.	Documentation on the project website will be reviewed and updated to ensure all drawings are on this portal.	Review and update will be completed by 15.05.2022.
